OROP – ISSUES TO BE RESOLVED

- Military Service Pay (MSP)**. Enhanced MSP for JCOs has been raised by IESL many times with the Govt. Every time the issue is put under the carpet without any logical or convincing reasons. The reasons for demand for enhanced MSP are as under:-
 - Even Nursing Offrs have been granted MSP who hardly go to sectors of service where threat to life exists. Secondly they are not Offrs as per DSR and they have been granted MSP of Rs 10,500/- per month.
 - JCOs are gazette Offrs class II and shoulder combat and admin responsibilities in combat zones. The JCOs are granted higher status in pay grade and hence MSP being "pay" should be Rs 10,500/- per month for JCOs.
- OROP Tables – Anomalies**. These anomalies have been fwd to Dept of (ESW) (MoD) and the numbers being large are sent separately. These have been prepared without any depth and dissection of accuracy.
- ECHS – Funds**. The funds allotted are too meager to mitigate the expenditure and balance of payment of previous years. It is strongly recommended that min Rs 6500 Crores to be allotted to meet the expenditure fairly. Every time we face a situation when empanelled hospitals refuse entertaining ESM patients even during medical emergency.
- Our delegation of three Services can give a presentation on this issues at any time required by the Govt.**
