

- 1. In the past 10 months IESL has tried all possibilities with official agencies to create self employment schemes for Veterans. We are of the view that the DGR is not in a position to provide jobs or self employment schemes for 50000 retiring personnel every year. Even then we received no positive response.
- 2. We suggested that ESM be given an opportunity to set up solar parks in military stations. Not more than five acres land is required for 2 MW parks. We were not given any positive response.

- 4. We will form a team to take up the proposals with PHDCCI. We hope other industry bodies and corporates also respond positively.
- 5. From my side I want veteran organizations and social media groups to circulate this widely so that maximum ESM are informed of this initiative and we help in providing them better source of income.
- 6. Once we finalise the proposals and circulate them, those desirous to participate will be asked to contact us directly.

A number of request have been received from ESM/Primary beneficiary wherein certain 64KB ECHS cards, have been blocked by the system as the Primary Beneficiary / ESM, has failed to upload documents to complete annual validation, inspite of availing Eligibility Extension provided on two occasions (One time eligibility extension by OIC Polyclinic and second time eligibility extension by Dir Regional Centre for three months respectively), as per policy letters mentioned at para 1.
- 3. Competent authority has approved **last and final** eligibility extension option to Primary Beneficiary / ESM, of three months to be granted by COECHS,to get their card unblock and annual validation to be carried out. All pending cases,to avail last and final eligibility extension option, for Annual Validation will be processed with recommendation of OIC Parent Polyclinic and Director Regional Centre before submitting to CO ECHS. Following action to be taken by various stakeholders: -
- 4. <u>Action by ESM / Primary Beneficiary</u>. ESM / Primary Beneficiary will take following actions for their dependents.
 - (a) Submit offline application alongwith the required self-attested documents separately dependent wise excluding parents to MD ECHS through respective OIC Parent Polyclinic and Director Regional Centre.
 - (b) Submit offline application combined together for his / her parents giving out status of mother and father duly dependent with required self/attested documents.
 - (c) Attach self-attested additional supporting documents required as per letters given at Para 1 above.
- 5. <u>Action by OIC Parent Polyclinic.</u> Process the application based on eligibility criteria and forward to Director Regional Centre with recommendation.
- 6. **Action by OIC Director Regional Centre.** Director Regional Centre will check the documents attached and give his recommendations and forward to Dir Vigilance at COECHS.
- 7. Action at CO ECHS. The application will be processed for approval of MD ECHS and decision will be communicated by Dir Vig to fwg:-
 - (a) ESM / Primary Beneficiary
 - (b) Director, Regional Centre
 - (c) OIC Parent Polyclinic
 - (d) SDCPL (Vendor)
 - (e) UTI ITSL (Vendor)

EXECUTIVE INSTRUCTIONS : DOMICILIARY MEDICAL EQUIPMENT FOR ECHS BENEFICIARIES

- 1. Please ref Central Org ECHS letter No B/49761/AG/ECHS/Medicine Policy/2023 dt 08 Dec 2023
- 2. It is clarified that it is responsibility of OIC, ECHS Polyclinic to ascertain that domiciliary med equipments demand in respect of an individual placed through SEMO is cancelled before processing prior sanction for individual reimbursement as per Para 3 (a)(i) as it would lead to double purchase. In such cases written confirmation from SEMO about cancellation of ECHS Polyclinic demand or supply order is mandatory before processing prior sanction.
- 3. It is also clarified that provision of Para 3(b) is applicable only for domiciliary med equipments with ceiling rates and those without ceiling rates will continue to be purchased as per Para 3 (a)(ii) only.
- 4. The letter mentioned at Para 1 above may please be treated as cancelled.

EXECUTIVE INSTRUCTIONS : DOMICILIARY MEDICAL EQUIPMENT FOR ECHS BENEFICIARIES

- 1. Please ref the fwg (copies attached) :-
 - (a) Gol (MoD/DoESW) letter No 24(8)03/US(WE)/D (Res) dt 19 Dec 2003.
 - (b) Min of Health & Family Welfare O.M. No. 1-19/2018/CGHS (HQ)/R&H/EHS dated 03 Jun 2019.
 - (c) GoI (MoD/DoESW) letter No 18(114)/2017/WE/D(Res-I) dt 18 Sep 2019.
 - (d) Min of Health & Family Welfare O.M. No. S.11011/37/2019-ECHS dated 01 Dec 2020.
 - (e) Central Org ECHS letter No B/49761/AG/ECHS/Medicine Policy/2022 dt 10 Jun 2022.
- 2. It is learnt from the environment that ECHS beneficiaries consisting mostly of aged indl and senior citizens are facing tremendous inconvenience while processing for domiciliary med equipments including some of life saving equipments. Due to prolonged existing procurement policy ESMs or their NoKs have to make multiple visits to ECHS Polyclinic or service hospitals for follow up, many times service hospitals fail to provide equipments and sometime quality issues plague our esteemed ESMs. The matter has been comprensively discussed with the competent authority and revised guidelines in respect of domiciliary medical equipments are as per succeeding paras. The prevailing CGHS rates of listed Domiciliary Medical Equipments are given in Appx.
- Issue Procedure.
 - (a) Individual Reimbursement: Grant of Prior Sanction. Based on advice of concerned Specialist of Service/Govt hosp, ECHS beneficiary has an option to purchase the Domiciliary Medical Equipment and claim reimbursement after taking prior approval as per following procedure:-

- (i) <u>Domiciliary Medical Equipment for Which Ceiling Rates are available</u>. ECHS beneficiary requests for prior sanction from concerned Director RC ECHS through OIC ECHS Polyclinic based on recommendation of concerned Specialist of Service Hospital or Government Hospital. Director RC ECHS will issue prior sanction letter to the individual beneficiary based on the recommendation of a/m specialists and request by the beneficiary. OIC ECHS Polyclinic will ensure that any similar demand is not being processed by SEMO and prior sanction is to be given to a beneficiary only after confirmation from SEMO in such cases.
- (ii) <u>Domiciliary Medical Equipment for Which no Ceiling Rates are available</u>. Domiciliary Medical Equipment other than those listed in Appx 'A', like Insulin pump etc which are issued to CGHS beneficiaries for which no CGHS ceiling rates exist and are recommended for domiciliary use for ECHS beneficiaries by Service Specialist/Govt Hospital Specialist will require prior sanction of the High Power Committee as mentioned vide Para 5 of Gol (MoD/DoESW) letter No 22A(37)2018/WE/D (Res-I) dated 15 Jan 2019. Composition of the High Power Committee would be as under:-

(aa) JS, ESW - Chairman

(ab) Government Hospital Specialist Doctor - Member (of concerned speciality)

(ac) Director/DS/US, DoESW - Member

(ad) Director (Medical), CO ECHS - Member-Secretary

(ae) Representative of MoD (Fin/Pen) - Member.

- (iii) Once prior sanction is obtained, the equipment can be purchased by the ECHS beneficiary and claim may be submitted to OIC PC who will verify equipment and documents and upload the claim as individual reimbursement on BPA portal. Veterns are at liberty to purchase higher quality equipments but reimbursement will not exceed prevailing CGHS rates as amended from time to time.
- (iv) Following documents should be submitted by ECHS Beneficiary for claiming reimbursement of Domiciliary Medical Equipment: -
 - (aa) Prior sanction letter of Director RC ECHS or High Powered Committee.
 - (ab) Original Bill of Domiciliary Medical Equipment.
 - (ac) Contingent Bill.
 - (ad) Cancelled Cheque/Bank details of beneficiary.
 - (ae) Copy of ECHS Card of beneficiary.
 - (af) Certificate from PC that the same type of equipment for the purpose was not issued in last five years.

- (b) Through SEMO. If a veteran does not want to avail the indle reimbursement route the Domiciliary Medical Equipment can be procured through SEMO also. Based on advice of concerned Specialist of Service/Govt hosp, OIC ECHS Polyclinic will forward demand to SEMO. SEMO will procure the said Domiciliary Medical Equipment and issue the same to the ECHS beneficiary. Copy of IVs and RVs will be forward to ECHS Polyclinic for record.
- 4. <u>Consumables</u>. The consumables for the equipments will be procured by SEMO/Comdt/CO Hosp and issued under arrangements of OIC Polyclinic. In case item is NA medical stores of Polyclinic, consumables will be issued through Authorised Local Chemist (ALC). If the same is not available in ALC/dispensary of ECHS Polyclinic then NA on prescription will be given to the beneficiary based on which he/she can purchase from local market and claim reimbursement.
- Repair & Maintenance/Annual Maintenance. Cost of repair & maintenance will be borne by the beneficiary themselves and will not be reimbursable.
- 6. <u>Replacement of Domiciliary Medical Equipment</u>. Request for replacement of Domiciliary Medical Equipment after completion of five years can be processed based on condition of the equipment. Following procedure will be adopted for Replacement of Domiciliary Medical Equipment:-

Based on Unserviceability Certificate, Replacement of Domiciliary Medical Equipment can be processed in similar manner as for the first issue of machine/equipment.
 - (b) <u>Domiciliary Medical Equipment procured by Individual Beneficiary</u>. If the Domiciliary Medical Equipment is non-functional after completion of five years of purchase, then Individual beneficiary should obtain Unserviceability Certificate from Aurhorised Service Enginner of OME of that Domiciliary Medical Equipment. Based on Unserviceability Certificate, Replacement of Domiciliary Medical Equipment can be processed in similar manner as for the first issue of machine/equipment.
 - (c) In case Domiciliary Medical Equipment becomes unserviceable before five yrs, the warranty conditions will apply if the eqpt is under warranty. If the warranty period is over, similar procedure as given out in Para 6 (a) & 6 (b) above will be followed.

Expenditure.

- (a) The expenditure on procurement of Domiciliary Medical Equipment by the SEMO will be debited to Major Head 2076 Minor Head 107 (C) Code Head 363/01.
- (b) The expenditure on procurement of Domiciliary Medical Equipment by the individual beneficiary will be debited to Major Head 2076 Minor Head 107 Code Head 365/00 for which the payment will be made by respective Regional Centres as per extant procedure for payment of individual reimbursement.

8. CFA.

- (a) <u>Domiciliary Medical Equipment procured by SEMO</u>. CFAs will be as per schedule 2.4, DFPDS-2016 as amended from time to time.

OIL PRODUCT AGENCY (OPA) DISTRIBUTORSHIP

Allotment of Oil Product Agency (OPA) Distributorship by Oil Marketing Companies Against 8% Reservation Quota

The Ministry of Petroleum and Natural Gas has a reserved quota of 8% for distributorship of Oil Product Agency i.e. LPG distributorship under Government Personnel (GP) category and Retail Outlets (Petrol/Diesel) under /CC1J category for eligible Armed Forces Personnel. The location for developing Retail Outlets and LPG distributorship are identified by the Oil Company after carrying out requisite feasibility study. Requirements for Retail Outlets and LPG distributorship in the particular locality are advertised through newspaper and the company's website. After publication of the advertisement, the applicant can apply directly to the Oil Company. Simultaneously, the applicant should apply for the DGR eligibility certificate which is required to be submitted to the oil company in original at the time of selection. The final selection is done through draw of lots by the oil company and office of DGR has no say in it.

Eligibility:-

- Widows/dependants of those who died in war.
- War disabled/disabled ESM due to attributable or aggravated causes to Military Service.
- Widows/dependants of those Defence personnel who died in harness due to attributable or aggravated causes to Military Service.
- ESM disabled in peace due to attributable or aggravated causes to Military Service.
- Able bodied ESM.

Govt. aided schools educational institutes, Military/ Sainik Schools and other schools and colleges recognised by the Central or State Governments including autonomous organisations financed entirely by the Central/ State Governments. Vide GOI, MOD letter No. 6(1)/2009/Edu Concessions / D (Res-II) dated 23 Mar 2018, the cap of Rs 10,000/- imposed on the combined amount of Tuition Fees and Hostel Charges vide Para 5 of the aforementioned letter is removed.

LIFE CERTIFICATE AND COMMENCEMENT OF FAMILY PENSION IN CASE OF PENSIONER LIVING ABROAD

Pensioner residing abroad have been facing various issues related to submitting Life Certificates or receiving a pension in their bank account. Following options are available to such pensioners in this aspect :-

Life Certificate for Pensioners Staying Abroad.

If the pensioner is drawing pension through any bank included in the Second Schedule to the Reserve Bank of India Act, 1934, the life certificate may be signed by an officer of the Bank.

An authorized official of the Embassy of India or High Commission of India or Indian Consulates may issue the life certificate.

In case the pensioner is unable to visit the Embassy or Consulate, the pensioner may submit requisite documents by post to the Embassy/Consulate, including Doctor's Certificate showing the pensioner's inability to present himself/herself in person. Embassy of India/High Commission/Indian Consulate may also assist pensioners/family pensioners in the submission of the Life Certificate.

A Pensioner, not resident in India, in respect of whom a duly authorized agent produces a Life Certificate, signed by a magistrate or a notary or an officer of an Indian authorized Bank or Diplomatic Representative of India, is exempted from special appearance.

There have been complaints that life certificate submitted over the counter of pension paying branches are misplaced causing a delay in payment of monthly pension. In order to alleviate the hardship faced by pensioners, agency banks are instructed to mandatorily issue duly signed acknowledgments. They were also advised to consider entering the receipt of life certificate in Core Banking Solutions which would serve the twin purpose of an acknowledgment as well as real-time updation of records.

Commencement of Family Pension. After the demise of a pensioner residing abroad, the following procedure will be followed for commencement of family pension:-

In case the pensioner and spouse are holding a joint account, the requirement of Form 14 has been dispensed with. The spouse may inform the pension disbursing Bank of the death of the pensioner and request the bank for the commencement of family pension, through a simple letter.

He/she may enclose a copy of death certificate of the pensioner, PPO, proof of his/her own age/date of birth and an undertaking for recovery of excess payment.

In other cases, i.e., where the pension is not being credited to the joint bank account of the pensioner, Form 14 will be continued to be obtained by the banks from the family pensioner. However, the condition of attestation of Form 14 has been done away with and witnessed by two persons has been considered as sufficient.

In case of family pensioners who are unable to visit India for personal identification, they may be allowed pension/family pension on the basis of a certificate to be issued by an authorized official of the Embassy of India/High Commission of India/Indian Consulate in the country where the pensioner is residing. This certificate is to be issued on verification of Pensioner/Family Pensioner on the basis of the photograph available in the pension payment order (PPO) or on the basis of the photograph available on the Passport.

The Army Group Insurance Fund (AGIF) for Army personnel was introduced with effect from 01 Jan 1976 by the Government of India. The aim of the scheme was to cater to the socio-economic needs of Army personnel and their families by maintaining a monthly contributory self-run scheme. To fulfill such a mandate, the AGIF runs the mandatory Group Insurance Scheme' for regular Army personnel. This insurance cover ceases at the time of retirement / release / discharge. The AGI Extended Insurance Scheme also known as 'AGIF EI-Scheme' is an extension of this insurance cover, post

retirement / release / discharge providing insurance cover up to a specified period by charging a one-time subscription to the AGIF member at the time of retirement / discharge / release.



The Board of Governors of AGIF approved the introduction of a mandatory Extended Insurance Scheme for all retiring members during its 8th Board of Trustees meeting. On retirement / release / discharge of the AGI member the regular insurance cover ceases. Maturity benefits are paid to the retiring personnel in lump sum. Hence, to provide insurance cover to retired Army personnel, Extended Insurance Scheme was started with effect from 01 Jan 1981 in respect of Officers and with effect from 01 Apr 1981 in respect of JCOs/OR against death for a specified period/prescribed age whichever is earlier.

Extended Insurance (EI) Scheme Contribution. A single non-refundable / refundable of premium at the rate decided from time to time by the Board of Governors is retained out of the maturity benefit amount payable at the time of retirement / release / discharge. El Certificate (as a digital copy) is issued to all eligible personnel via email through respective Records Office in case of JCOs and OR and directly via email in case of officers. The one- time subscription charged is refundable in the modified scheme applicable to members retiring on or after 31 May 2022 as follows:-

ranks re-employed in the Army or DSC enjoy regular insurance cover as applicable to regular army personnel Insurance rules do not permit an individual to be a member of two group insurance scheme. Hence, the Extended Insurance cover to re- employed personnel and veterans serving in DSC TA remains suspended during the period of re- employment.

Refund of Contribution Value for Period of El Cover Suspension. On termination of reemployment / DSC / TA-service.the Extended Insurance cover is revived. Since the premium has already been recovered for a lower age bracket and the Extended Insurance cover is revived at a higher age bracket, a pro-rata refund of premium is given to such personnel for the period they were covered by regular insurance cover during the period of re-employment.

Processing of Extended Insurance Claim.

Claim for death benefits must be submitted by the nominee in accordance with the procedure laid down in the Extended Insurance Certificate itself issued to retirement/release/discharge. On receipt of El Claim documents online payment via NEFT is made by AGIF to the beneficiary bank account.

Documentation. Essential documents to claim the Extended Insurance (EI) are:-

- ➤ In case the claimant is Nominee or Contingent Nomince
- Death certificate of member (Veteran) with scan BAR CODE.
- Extended Insurance (EI) certificate in original, if available.
- Cancelled cheque (or) 1st page of bank pass book copy with name of claimant to be printed on it. This is required to ascertain the Account No to credit the proceeds through NEFT/RTGS.
- Copy of AADHAR card of NOK (Claimant) for identification mentioning Mob/Contact number of claimant.

- ➤ Claimant other than Nominee / Contingent Nominee. The Extended Insurance (EI) amount will be distributed amongst remaining Class I legal heir. If none of the Class I legal heirs survive, then the amount may be claimed by Class II legal heirs. The list of documents to be submitted is as follows:-
- \cdot Death certificate of member (Veteran) with scan BAR CODE.
- Death certificate of Nominee, Contingent Nominee with scan BAR CODE.
- Cancelled cheque (or) 1st page of bank pass book copy with name of claimant beneficiary printed on it. This is required to ascertain the Account No to credit the proceeds through NEFT/RTGS.
- Copy of AADHAR card of NOK (Claimant) for identification mentioning Mob / Contact No of claimant of each beneficiary.
- · Claim affidavit (as per format by each beneficiary).

Cases Ineligible for El Cover. The AGI El scheme cover is not applicable to deserters, individuals on deputation from P & T Department who do not retire from Army and individuals who do not have adequate balance for recovery of single non-refundable premium at the time of retirement.


