

Dears Members of IESL Jay Hind

- 1. Two months have passed since the last issue of the Indian Ex-Serviceman.
- 2. In this period alongwith other appointments I tried my best to make some progress in the resolving anomalies, especially of OROP-2. Regretfully no action is being taken by Service HQ. What is the way out? I discussed the problems with the Executive Council Members and I conveyed that only option is to knock the doors of the Courts. Since the next equalisation is due from 01 Jul 2024, we decided to wait for two more months to see what the govt decides.
- 3. Our Solar Panel System is working satisfactorily and our bill has come down to Rs 14000/- pm from about Rs 40000/-pm in the hot season. Saving approx Rs 25,000/-pm.
- 4. Our plan of constructing two additional floors is in the final stages of approval and we hope to get the NOC within the month of May 2024. With the construction of the building within this year, we expect to get additional rent anywhere between Rs 4.50 Lakhs to 6.00 Lakhs per month depending on the area of construction allowed. This will help IESL to be financially more secure and we can then undertake more welfare activities.
- 5. We have become member of PHDCCI which one of the oldest body of industries. I can assure the members that we will benefit from this association. Till we get into some good and safe investment opportunities with the industries we will not be able to help our members, State Bodies and HQ IESL. I can assure you if all goes well we will achieve much more that what we can get through DGR or any govt programme. Nothing is forthcoming from the official circles of service HQ or MoD.
- 6. Finally I would like to convey that we have to be on our own feet. Help from govt or Service HQ is not forthcoming.

- 3. हमारा सोलर पैनल सिस्टम संतोषजनक ढंग से काम कर रहा है और गर्मी के मौसम में हमारा बिल लगभग 40000 रुपये प्रति माह से घटकर 14000 रुपये प्रति माह हो गया है। प्रति माह लगभग 25.000 रुपये की बचत हो रही है ।
- 4. दो अतिरिक्त मंजिलों के निर्माण की हमारी योजना मंजूरी के अंतिम चरण में है, उम्मीद है की मई 2024 के भीतर एनओसी मिल जाएगी । इस वर्ष के भीतर भवन के निर्माण के साथ, हमें 4.50 लाख से 6.00 लाख रुपये के बीच अतिरिक्त किराया मिलने की उम्मीद है। इससे आईईएसएल की स्थिति और अधिक अच्छी होगी और हम अधिक कल्याणकारी गतिविधियां चला सकेंगे।

DO LETTER WRITTEN BY PRESIDENT, IESL TO FORMER CHIEFS OF ARMY STAFF

IESL/105/2024 04 Apr 2024

My dear General,

- 1. I take this opportunity of addressing you as also all the former Chiefs of Army Staff through this letter.
- 2. I' sure you are aware of the existence of IESL and you have also had the privilege of being the Patron of IESL during your tenure as Chief.
- 3. You would be aware of the problems faced by the Veterans. I will only restrict myself to major issues in which the Govt has a role. First the anomalies arising out of OROP and OROP-2 which is the equalization implemented with effect from 01 Jul 2019. Then there are issues of migration of pension to SPARSH. Inaccuracies in data is the main issue being faced by ESM. There is a variation in pension of similarly placed ESM. And the third major problem is the functioning of ECHS. Medicines are in short supply. Staff strength at ECHS Poly Clinics has been reduced. The outstanding bills of empanelled hospitals is another issue. This leads to frequent empanelling and dis-empanelling of hospitals.
- 4. Since all of you have served with your Regts / Bns troops and thereafter as formation commanders up the chain, I assume you would be maintaining close relations with ESM from your Regts. I wonder why these problems have never crossed your mind.
- 5. We place our Army above everything and our troops at the highest pedestal. The entire country saw our former Chiefs at Ayodhya for the consecration ceremony of Shri Ram Mandir. Wouldn' it be appropriate if all of you get together and meet the PM and asked him to address the critical issues of ESM. Infact the rank and file is wondering whether the former Chiefs consider themselves as ESM. We are aware you would not be facing any of the issues which I have reflected in Para 3
- 6. I'e been a member of IESL for the past 13 years. We have had only one serving Chief visit us in the last 10 years. We get no financial help from the MoD or any of the Service HQs. Even the Govt of India has not contributed a single rupee to IESL. We are grateful to the Govt that was kind enough to give IESL about 2000 sq yds land in 1964 on perpetual lease. Possibly the Govt of the day listened to our founders, Gen KM Cariappa and Gen KS Thimayya. Compare this with the support extended by the British Govt to the Royal Commonwealth Ex-Services League (RCEL).
- 7. It was with some vision that our founding fathers appointed the serving Chiefs of three services as Patron and the Raksha Mantri as the Patron in Chief. I doubt if any of you discharged any responsibility as Patron. May be embarrassing, especially in these times of disowning everything British about the Indian Army, the Royal Commonwealth Ex Services League is the only orgnisation which extended financial support to WW-2 veterans through us, as also in the construction of our building. Some help came from a couple of corporates.
- 8. My approach to the Service HQs, including the CDS and the three Chiefs has also not elicited any positive response.
- 9. All of you occupied the chair once occupied by Gen KM Cariappa and Gen KS Thimayya. I don' know whether the chair used by Gen Cariappa is still being used by the present Chief. We in our office have preserved and placed the chair which our founder occupied in our office with his photograph as we are the Custodian of the Chair of Gen KM Cariappa.
- 10. May I request you to do whatever you can in helping the ESM. In absence of residential address of most of our former Chiefs, I am circulating this letter through Social Media. Those whose address we have or get it I will forward a hard copy.

Please refer your letter IESL/105/2024 dated 04 Apr 2024

- I have had the privilege to visit the IESL complex when I was the COAS. The complex cedainly needs to be taken care of and some permanent arrangement needs to be worked out. My suggestion is that the CDS and three Chiefs take up the issue with the Raksha Mantn. They should work out the modicum of how to fund the IESL so that the complex can be taken care of and in the long run become self sustaining.

Office Memorandum

Subject: Amendment to CCS (Pension) Rules, 2021 – Allowing female Government servants/female Pensioner to nominate her child/children for family pension in precedence to her husband in the event of marital discord leading to filing of divorce proceedings in a Court of Law or filing of a case under Protection of Women from Domestic Violence Act or Dowry Prohibition Act or Indian Penal Code-reg.

The undersigned is directed to state that, as per the provisions of sub-rule (8) and sub-rule (9) of Rule 50 of CCS (Pension) Rules, 2021, if a deceased Government servant or pensioner is survived by a spouse, family pension is first granted to the spouse and the children and other family members become eligible for family pension, on their turn, only after the spouse of the deceased Government servant/pensioner becomes ineligible for family pension or dies.

- 2. This Department has been receiving a large number of references from Ministries/Departments, seeking advice as to whether a female Government servant/female Pensioner can be allowed to nominate her eligible child/children for family pension in place of her spouse in the event of marital discord leading to filing of divorce proceedings in a Court of Law or filing of a case under Protection of Women from Domestic Violence Act or Dowry Prohibition Act or under Indian Penal Code.
- 3. The matter has been examined in consultation with Ministry of Women and Child Development. Accordingly, it has been decided that in case divorce proceedings in respect of a female Government servant/female pensioner are pending in a Court of Law, or the female Government servant/female pensioner has filed a case against her husband under Protection of Women from Domestic Violence Act or Dowry Prohibition Act or under Indian Penal Code, such female Government servant/Female Pensioner may make a request for grant of family pension after her death to her eligible child/children, in precedence to her husband and such request may be considered in the following manner:
 - (a) Where, in respect of a female Government servant/female pensioner, divorce proceedings are pending in a competent Court of Law, or the female Government servant/female pensioner has filed a case against her husband under Protection of Women from Domestic Violence Act or Dowry Prohibition Act or under Indian Penal Code, the said female Government servant/female pensioner, may make a request in writing to the concerned Head of Office to the effect that, in the event of her death during the pendency of any of the aforesaid proceedings, family pension may be granted to her eligible child/children in precedence to her spouse;
 - (b) In the event of the death of the female Government servant/female pensioner, who had made a request under clause (a), during the pendency of any of the aforesaid proceedings, the family pension shall be disbursed in the following manner, namely:

- (i) Where the deceased female Government servant/female pensioner is survived by a widower and no child/children is eligible for family pension on the date of death of the female Government servant/female pensioner, family pension shall be payable to the widower.
- (ii) Where the deceased female Government servant/female pensioner is survived by a widower with a minor child/children or a child/children suffering from disorder or disability of mind including the mentally retarded, the family pension in respect of the deceased shall be payable to the widower, provided he is the guardian of such child/children and if the widower ceases to be the guardian of such child/children, such family pension shall be payable to the child through the person who is the actual guardian of such child/children. Where the minor child, after attaining the age of majority, remains eligible for family pension, the family pension shall become payable to such child from the date on which he/she attains the age of majority.
- (iii) Where the deceased female Government servant/female pensioner is survived by a widower with a child/children who has/have attained the age of majority but is or are eligible for family pension, the family pension shall be payable to such child/children.
- (iv) After the child/children referred to in clause (ii) and (iii) above cease to be eligible for family pension under Rule 50 of the CCS (Pension) Rules, 2021, family pension shall become payable to other child/children, if any, eligible for family pension.
- (v) After all the children cease to be eligible for family pension under Rule 50 of the CCS (Pension) Rules, 2021, family pension shall become payable to the widower till his death or remarriage, whichever is earlier.
- 4. All Ministries/Departments are requested to bring the contents of this order to the notice of Controller of Accounts/Pay and Accounts Officers and Attached, Subordinate Offices and Autonomous bodies under them.
- In so far as the persons serving in the Indian Audit and Accounts Department are concerned, these orders are issued in consultation with Comptroller and Auditor General of India, as mandated under Article 148(5) of the Constitution of India.

Sub: Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 01.01.2024-reg

The undersigned is directed to refer to this Department's OM No. 42/04/2023-P&PW(D) dated 27.10.2023 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/Family Pensioners shall be enhanced from the existing rate of 46% to 50% of the basic pension/family pension (including additional pension/family pension) w.e.f 01st January,2024.

- These rates of DR will be applicable to the following categories:-
 - (i) Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
 - (ii) The Armed Forces Pensioners/Family Pensioners and Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates.
 - (iii) All India Service Pensioners/Family Pensioners.
 - (iv) Railway Pensioners/Family Pensioners.
 - (v) Pensioners who are in receipt of provisional pension.
 - (vi) The Burma Civilian Pensioners/Family Pensioners and Pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11.09.2017.
- The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- The payment of arrears of Dearness Relief shall not be made before the date of disbursement of pension/family pension of March, 2024.
- 5. Other provisions governing grant of DR in respect of employed family pensioners and reemployed Central Government Pensioners will be regulated in accordance with the provisions contained in Rule 52 of CCS (Pension) Rules, 2021 and this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.

- In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 8. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of Dearness Relief to Pensioners/Family Pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- In so far as the persons serving in Indian Audit and Accounts Department are concerned, these
 orders are issued in consultation with the Comptroller and Auditor General of India, as mandated
 under Article 148(5) of the Constitution of India.

ADVISORY: NOMINATIONS

We have our pension coming to the Bank account through the Pension Disbursing Agency - DPDO/ CPPC, now through SPARSH. It is important to declare nominee for the bank account and for claiming Life Time Arrears (LTA).

- <u>JOINT A/C FOR PENSION</u>: The pensioners must open a joint pension a/c with their Spouse.
 On demise, the balance in the joint a/c will pass on to the survivor, ie the Spouse, being the secondary account holder. The Family pension will also commence in this account w/o opening another a/c.
- NOMINATION IN THE BANK A/C: The nominee assumes importance in case of a single pensioner/account holder. The declared Nominee will be authorised to withdraw the balance amount from this a/c.

NOMINATION FOR LIFE TIME ARREARS (LTA)

The nomination for LTA is essential so that after the death of the pensioner, all dues to the pensioner are paid to the Nominee.

The pensioner is required to submit "FORM A" to PCDA (P), Pension Disbursement Authority (DPDO/CPPC of the Bank), Bank Branch and retain one copy. Format for "FORM A" is given as per the link below: https://pensionersportal.gov.in/forms/nominationFormA.pdf

FORMULATION OF POLICY AND PUB OF PART-II ORDERS IN RESPECT OF RETD OFFRS

- 1. Officers Record Office (ORO)/ MP-5 is the custodian of approx 92.000 documents of Veteran offrs/NsOK and resp for maint, processing of all disability, pensionary claims and handling offline/online grievances of Veteran offrs/NsOK. No provision existed in the Documentation Procedure for Offrs-2014 to publish pt II orders for retd offrs and same was carried out by MPRS(O) & TA Dte in manual mode. Moreover, PT-II orders of retd JCOs/OR were published by respective Record Offices.
- 2. In absence of such provisions data updation/correction in respect of Indian Army veteran offrs was carried out by MP 5/ORO manually on receipt of requisite docu as per PCDA (P)guidelines Post requisite verification/ legal vetting of the docu necessary amdts/updates were made in the Record of Service (RoS) and accordingly cases were processed with PCDA (O)Pune/ PCDA (P) Prayagraj with intimation to the offr concerned.
- 3. Numerous requests/ representations were recd from the veterans for publication of cas post retirement. PCDA (O) Pune and PCDA (P) Prayagraj had also requested for publication of digitally signed part II orders for release of benefits/updation of data accordingly. Case was processed for obtaining separate SUS No for MP-5/ORO to facilitate publication of part-II orders in r/o veteran offrs/ NsOK/ dependents.
- 4. HRMS appin software which is used to publish part II orders for serving personnel has now been customized to also publish part II orders of veteran offrs. Part-II module on HRMS is now fully functional and is compatible with corresponding software/utility of PCsDA. Publication of Part-II orders in r/o veteran offrs will ensure accountability, transparency and mgt of records.
- 5. It is requested to give wide publicity to the devp and disseminate the same to offices dealing with veteran offrs.

EQUIPMENT FOR ECHS BENEFICIARIES

- 1. Please ref Central Org ECHS letter No B/49761/AG/ECHS/Medicine Policy/2023 dated 30 Nov 2023.
- 2. As per existing policy on procurement of domiciliary med eqpt, various types of aids/eqpts are being purchased through SEMOs. It has been brought to notice that many such eqpts particularly hearing aids are not being collected by ECHS beneficiaries after procurement due to various reasons. As these eqpts do not have indefinite shelf life they need to be utilized adequately within its useful shelf life. As wait for collection can not be Indefinite a need is felt to frame suitable guidelines for judicious use of procured domiciliary aids/ eqpts out of govt fund.
- 3. Guidelines on the subject matter are as follows:-
 - (a) Domiciliary eqpts are mandatorily needed to be collected within 60 days from date of taking on ledger at med store of service hospital. All possible effort should be made by ECHS PC to liaise with the ECHS beneficiary to collect it within 60 days.
 - (b) Beyond 60 days SEMO is hereby authorised to issue the same eqpt to any other suitable ECHS beneficiary for whom recommendation matches available left over domiciliary eqpt.
 - (c) A reconciliation certificate needs to be issued by SEMO stating that domiciliary med eqpts purchased in name of one indl is now being issued to a new indl due to non collection by the previous beneficiary.
 - (d) The manufacturer warranty should start from date of issue to new ECHS beneficiary (suitable changes in terms & conditions may be incuded by SEMO during procurement process of such eqpts). Its maintenance, repair and replacement will be governed as per a/m letter under reference.
 - (e) The ECHS beneficiary in whose name the domiciliary med eqpt was originally purchased should be banned for next 06 months from date of issue to the other ECHS beneficiary for processing demand for similar type of eqpt again.



 - (b) The policy letter dated 10 Apr 2018 further clarifies that where invoice is uploaded with MRP on sticker/ Packet, the rate should be same and if there is a variation, the lowest rate is applicable.
- 3. From the above, it is clear beyond doubt that invoice is required in every claim. The fresh advisory dated 02 Feb 2023 further brings out that the details like batch/lot no in the uploaded vial or pouch should be the same as mentioned in the invoice. The hospital invoice bearing the GST & DL number would suffice. As per CGHS rates, which are applicable for ECHS, there is no restrictions on MRP being mentioned in the invoice. However, under no circumstance can the invoice price exceed the MRP.

ADVISORY: DISPOSAL OF NSP WEAPON

- A large number of Veterans are in possession of NSP weapons. Disposal of these weapons is a matter of common concern. The Veterans in possession of weapons must familiarize themselves with the Arms Act, amendments if any (Arms Act of 1959 read in conjunction with Arms (Amendment) Act 2019), and the relevant Army Orders (SAO 4/S/2006, AO227/75, SAO6/S/81).
- 2. Entitled Personnel as per Army Order.
 - (a) Serving Army Officers
 - (b) Retired Army Officers

- All Weapons
- All Weapons less "Prohibited Bore"
- Carbine.30, Rif.30BA df & SBBL

- (c) JOOs
- (d) Civilian Gazetted Officers (Serving Class I only)

- Pistel/ Revolver.32 & 12 Bore SBBL/DBBL
- The options available for disposal of NSP Weapon are as under:
 - (a) Transfer of weapon to Another Entitled Personnel- Officer/JCO (Serving/Retired).
 - (b) Return the Weapon to the Ordnance Depot.
 - (c) On Demise of a NSP Weapon Holder, the legal heirs may apply for retention as family heirloom on sentimental reasons.
- Procedure. The Disposal of the NSP Weapon can be carried out only after the approval of the Standing Allotment Committee (STC). The documents required to be submitted are as under.

 - (iii) Certificate from the Transferee that "I am not in possession of any NSP weapon allotted to me through Ordnance or transferred by any other entitled person"- Appendix "C"
 - (iv) Photocopy of the Issue Voucher of the Weapon issued by the Ordnance.
 - (v) In case of loss of Issue Voucher, an Affidavit as per Appendix 'F'
 - (vi) Legible copy of the Valid Arms License of the Transferor and the Transferee (If retired).
 - (vii) If Arms License is not renewed, an Affidavit on Rs 10/- Non Judicial Stamp Paper attested by Notary, sample at Appendix 'G'
 - (b) Return the Weapon to Ordinance Depot.
 - (i) Application from the Weapon Holder-Appendix 'D'.
 - (ii) Photocopy of the Issue Voucher of the Weapon issued by the Ordnance.
 - (iii) In case of loss of Issue Voucher, an Affidavit as per Appendix 'F'.
 - (iv) Legible copy of the Valid Arms License of the Weapon Holder.
 - (v) If Arms License is not renewed, an Affidavit on Rs 10/- Non Judicial Stamp Paper attested by Notary, sample at Appendix 'G'.
 - (c) On Demise of a NSP Weapon Holder, the legal heirs may apply for retention as family heirfoom on sentimental reasons.
 - (i) Details of the NSP Weapon Holder -Appendix 'E'
 - (ii) Application from the Transferee Appendix 'B'
 - (iii) Legible copy of valid arms license of the transferee.
 - (iv) Certificate from the Transferee that "I am not in possession of any NSP weapon allotted to me through Ordnance or transferred by any other entitled person". Appendix "C"
 - (v) Photocopy of the Issue Voucher of the Weapon issued by the Ordnance.
 - (vi) In case of loss of Issue Voucher, an Affidavit as per Appendix F
 - (vii) Legal Heir Certificate

PPO is the most important document after retirement, we advise you to keep is securely and keep your spouse/ family members aware of where it is kept.

Please check your PPO thoroughly going through each column and row carefully for correctness:-

Personal Particulars

- Army No, rank and name should be correct.
- Name Spellings of the name of self, spouse and dependents is required to be identical in all documents viz. PPO, Aadhar, PAN, Bank, Service Booklett/ Discharge Book & Passport. etc.
- Date of Birth Similarly DoB in respect of yourself & Spouse needs to be correct as per documents and accordingly endorsed for necessary financial benefits that would accrue on attainment of 80/85/90/95/100 years of age.
- Handicap Child/ Widowed/Divorced/Unmarried Daughter In case of handicap child, widowed/divorced/unmarried daughter's name should be endorsed in PPO.
- Date of Enrolment/Commission & Date of commencement of pension should be correct in the PPO.
- Qualifying Service (QS) in terms of years/month/days must be accurately
 endorsed. Ensure that in case of offrs with pre-commissioned service, te
 same is duly included in QS.
- **Type of Pension** Service/Disability/War Injury/Family Pension-LFP, SFP, OFP/Dependent.
 - Rate of Family Pension-LFP/SFP/OFP including the enhanced rate.
- Gratuity & ECHS contribution.
- **Commutation** Amount and date of Absolute Commutation (It could be in variance with date of retirement).
- **Details of Spouse** Name and date of birth and aligned with Aadhar and PAN Card. (In case only age and year of birth is mentioned-approach Records Office/ MP5).

Details of Bank

- Correctness of account number & bank details.
- Ensure your pension joint account with spouse & you as the primary account holder.
- Ensure nominee is designated for the bank acct

Corrigendum PPO

- Original PPO is the most important document.
- Corrigendum PPOs are issued when any change in the structure of basic pension or any correction in the service particulars is made.

ADVISORY: IMPORTANT DOCUMENTATION AFTER RETIREMENT

- Documentation after retirement continues to be as important as it was during service. Our pension, entitlements and welfare schemes are directly dependent upon correct documentation.
- After retirement, the documents are processed with the respective Records/ORO initiated by concerned Zila Sainik Board.
- Service Particulars Booklet/ Discharge Book issued at the time of retirement by ORO/ Depot Coy: contains service particulars, family details, permt address etc.
 Personal particulars in all documents should be same, incl spelling: PPO, Aadhaar, PAN, Bank Account, ECHS, Passport, DL, Voter ID, I Cards etc.

ADVISORY: DEMISE OF A SERVING SOLDIER IMPORTANT POINTS FOR THE SPOUSE/ NOK

In case of Demise of a Serving Soldier, the initial pension and documentation for all entitlements are processed/ assisted by the Unit. The unit detail a special courier to Records Office/ ORO/ MPRSO, PAO/ PCDA(O)/ PCDA(P), AGIF, ZSB and all other concerned establishments. The progress of documents is required to be updated to DIAV by concerned agencies involved. The Complete pension process is now initiated online through SPARSH.

Once the pension commences and other terminal benefits are settled, the Spouse/ NOK need to know some important issues related to his/ her pension and entitlements.

- PPO. It is the most important document. Pension notified as Ordinary/ Special/
 Liberalised (OFP/SFP/LFP). Please ensure that the entitled family pension is correctly
 revised as per OROP Tables and CPC, specially in respect of legacy Family Pensioners.
- NoK must obtain Descriptive Roll from Records Office/ MP5/ MPRSO, giving service particulars of the deceased and other personal details.
- Ensure Nominee for Bank a/c and Life Time Arrears are notified.
- In case of AGIF deposits under Social Security Deposit (SSD) Schemes, receipt be kept in safe custody and maturity period be noted.
- Register with ZSB for entitlements/ welfare schemes/ employment offered by the State Government and apply for Widow/ War Widow/Dependent Identity Card from ZSB.
- Apply for CSD Cards as primary beneficiary.
- Apply for online 64 KB ECHS Card for self as primary beneficiary and dependents.
- Register with DGR for any eligible scheme.
- Register self/ dependents with AWPO for employment opportunities in the corporate sector.
- Register with DIAV for any assistance, download registration form given in the link; https://www.indianarmyveterans.gov.in/download.html
- BC cases to Obtain Entitlement Card for Children Education Grant through Records Office/ ORO.
- BC cases entitled 100% reimbursement of Tuition & Hostel fee till Graduation. Apply for Education Grant up to Graduation with CW3 as per the link given below: https://www.indianarmyveterans.gov.in/grants.html
 - Grants to the Fatal Cases(BC & PC) through DIAV:
 - Education Grant to BC-for PG & Professional Courses for Wards

- System for Pension Administration Raksha (SPARSH) has been implemented for sanction and disbursement of Pension for all Defence pensioners.
- "The aim is "Right Pension at Right Time" through a secure and reliable digital platform.

The major features are:

- Centralized sanction, claim and disbursement of pension.
- Easy validation and rectification of data
- Digital process for pensioner identification.
- Real time tracking of grievances.
- The system would cater to all activities of the pension cycle namely:
- Initiation and Sanction
- Disbursement
- Revision
- Service and Grievance Request Management
- Know Your Migration Status

- · Go to "Services"
- Under 'Track', click on "Know Your SPARSH PPO and Identification Status"

- Password: A system generated password through SPARSH website. In case no such message received, go to 'Forget Password' and new system generated password will be received.
- Once logged in, you will be prompted to create your own password and login.
 Remember this PASSWORD.
- Personal Data Verification : PDV
- Using the system provided login credentials, the pensioner will be able to log on to the SPARSH Pensioner Portal for initiating the 'verification of data'.
- · After initial login a window showing PDV will appear.

- Personal data is made available in SPARSH Portal to facilitate the pensioner to scrutinize.
- Clicking on 'next' 'next' till the last pop up, it will take you to Aadhar based e-authentication through an OTP.
- · Updating of Aadhar and PAN Cards
- · After Login, Select ' Manage Profile
- ' and update your Aadhar Card details else your digital life certificate (DLC) will not be updated Similarly in case your PAN card number is not updated, your income tax will continue to be deducted at specified flat rate.

ADVISORY:

ENDORSEMENT/ CHANGE/ CORRECTION NAME & DOB OF SPOUSE IN PPO/ SPARSH

The Spouse of an ESM is the first claimant of Pension & Entitlements on his/ her demise. It is important that details of spouse are correctly notified in PPO. There are elderly Veterans who retired when such provisions were not existing and many later retirees may have incorrect/ incomplete details of spouse endorsed in PPO/ SPARSH.

Please also remember, details in the Record of Service alone do not make the spouse automatically entitled to pension and entitlements. Endorsement in the PPO/ SPARSH is essential.

- Above actions are essential only then can the desired changes can affected SPARSH.

ADVISORY: MEDICAL CARE OF ESM IN MILITARY HOSPITALS IN EMERGENCY AND LIFE THREATENING CONDITIONS

- 1. While the ECHS organization was created on 01 Apr 2003 with the aim to provide comprehensive medicare to the retirees of Armed Forces, care of ESM still remains one of the important and sensitive functions of Military Hospitals. Grievances and complaints on various issues varying from refusal of admission to inadequate medical care at Mil Hosp are received from ESM. Majority of these complaints can be addressed if patients are attended to with empathy and patience.
- In order to facilitate the emergency medical care of ESM, following actions will be ensured by all Military Hospitals.
 - (a) No ESM reporting for emergency and life saving care will be denied admission
 - (b) Any decision to refer the patient to an empanelled hospital will only be taken with due clearance from Combt/CO/HoD
 - (c) When an ECHS member ESM is referred to an empanelled hospital, all possible assistance in terms of contact with the empanelled hospital, ascertaining bed availability, details of ambulance services for transfer of patient etc will be provided to the relatives/ attendants of the patient.
 - (d) The role of the Mil Hosp will continue till the patient is admitted to the empanelled hospital.
 - (e) The record of all such patients will be maintained by the Mil Hosps and will be monitored by Comdt/ CO hosp for effective implementation of the instructions.
