



Subject: Conditions for grant of additional pension to the retired Central Government Civil Employees covered under Central Civil Services (Pension) Rules, 2021- reg.

The undersigned is directed to say that as per the provisions of Sub Rule 6 of Rule 44 of CCS(Pension) Rules 2021 [erstwhile Rule 49(2-A) of CCS(Pension) Rules 1972), after completion of eighty years of age or above by a retired Government servant, in addition to a pension or a compassionate allowance admissible under the rules, additional pension or additional compassionate allowance shall be payable to the retired Government servant in the following manner:

Age of pensioner	Additional pension/additional compassionate allowance
From 80 years to less than 85 years	20% of basic pension/compassionate allowance
From 80 years to less than 90 years	30% of basic pension/compassionate allowance
From 80 years to less than 95 years	40% of basic pension/compassionate allowance
From 80 years to less than 100 years	50% of basic pension/compassionate allowance
100 years or more	100% of basic pension/compassionate allowance

- 2. The additional pension or additional compassionate allowance shall be payable from first day of the calendar month in which it falls due. For example, a pensioner born on 20th August, 1942 shall be eligible for additional pension at the rate of twenty percent of the basic pension with effect from I st August, 2022. A pensioner born on I st August, 1942 shall also be eligible for additional pension at the rate of twenty percent of the basic pension with effect from Ist August, 2022.
- 3. All Ministries/Departments and Pension Disbursing Authorities/Banks are requested that the above provisions of Central Civil Services (Pension) Rules, 2021 may be brought to the notice of all concerned for compliance.

ADVISORY PENSION PAYMENT ORDER (PPO)

PPO is the most important document after retirement, yes even dearer than the 'Janam Patri'. Please check through each column and row carefully.

- Personal details (spelling) of self and spouse should be aligned with all documents viz. Adhar, PAN, ECHS, CSD, Bank, DL, Passport etc.
- 2. Army No, rank and name should be correct.
- 3. Date of birth, enrolment /commission, commencement of pension.
- 4. Qualifying Service in terms of years/months/days including the pre-commissioned service, if any.
- 5. Type of pension Service/ Disability/ War Injury /Family Pension LFP, SFP, OFP/ Dependent.
- 6. Gratuity & ECHS contribution.
- 7. Amount and date of Absolute Commutation (It should be in variance with date of retirement).
- 8. Details of spouse: Name and date of birth and aligned with Adhar and PAN Cards, (In case only age and year of birth is mentioned- approach Record Office/MP5)
- 9. Rate of Family Pension- LFP / SFP / OFP including the enhanced rate.
- 10. Details of children/ Dependents.
- 11. In case of handicap child, widow/ divorce/ unmarried daughter's name should be endorsed in PPO.
- 12. Details of Bank and account number- ensure it is a joint account with spouse.

Corrigendum PPO

Original PPO is also an equally important document. Corrigendum PPOs are issued when any change in the structure of basic pension or any correction in the service particulars is made.

Note: On introduction of SPARSH, these details be checked after "login" to SPARSH

Office Memorandum

Subject: Clarification on deletion of name of daughter from the family details of a Central Government pensioner.

- 1. The undersigned is directed to say that the Department of Pension and Pensioners' Welfare's notified the Central Civil Services (Pension) Rules, 2021 in supersession of the Central Civil Service (Pension) Rules, 1972.
- 2. Rule 50 (15) of the CCS (Pension) Rules, 2021 provide that as soon as a government servant enters government service, he shall give details of his family in Form 4 to the Head of Officer which shall include all relevant details relating to spouse, all children, parents and disabled siblings (whether or not eligible for family pension). This Rule further provides That the government servant shall submit the up-to-date details of the family in Form 4 again along with the pension papers, before retirement from government service.
- 3. References were received seeking clarification in respect of deletion of name of the daughter from the details of family members after retirement of the government servant.
- 4. It has been clarified by this Department vide OM No. 3(2)/2022-P&PW(H)-7942 dated 07-10 2022 that the Government servant/pensioner shall submit details of all member of family whether or not eligible for family pension. The daughter is deemed to be a member of the family of Government servant as and when intimated by the Government servant in the prescribed proforma hence the name of the daughter shall remain included in the details of family members. The eligibility for family pension would be decided after demise of pensioner/family pensioners in accordance with the existing rules.
- 5. All Ministries / Departments are requested that the above provisions may be brought to the notice of the personnel dealing with the pensionary benefits in the Ministry / Department and attached / subordinate offices thereunder for compliance.

ASSURED DECENT LAST RITES SCHEME (ADLRS) EXPLAINED

The Assured Decent Last Rites Scheme (ADLRS) was introduced in May 2006 by the Indian Armed Forces to guarantee that all willing veterans receive an honorable funeral. This initiative serves as a final tribute to their service to the nation and is designed to provide immediate assistance to the family of a deceased veteran, ensuring that their last rites are conducted with dignity and respect.

Concept of ADLRS

The primary objective of the ADLRS is to uphold the moral responsibility of the Army towards its veterans. An organizational setup has been established at each Canteen Stores Department (CSD) Canteen, where veterans are registered. Upon the passing of a veteran, field staff are dispatched to the residence of the deceased to assist the family in organizing the funeral. If necessary, the field staff will take over the arrangements and ensure that the last rites are conducted appropriately. The scheme also guarantees that a wreath is placed on behalf of the Chief of the Army Staff (COAS) as a tribute to the deceased. Overall management and financing of the scheme are handled by the CSD Canteen to which the deceased veteran was last attached.

Eligibility for ADLRS

All veterans from the Army, Navy, Air Force, and Assam Rifles, including officers, Junior Commissioned Officers (JCOs), Other Ranks (ORs), and their widows, are eligible for this scheme, provided they hold valid CSD canteen cards and are dependent on an Army-run CSD Canteen.

Financial Assistance

The next of kin (NOK) of the deceased veteran is entitled to financial assistance under the ADLRS, structured as follows:

- For the **Army**, an amount of ₹10,000 is disbursed through the arrangements made by the Station Headquarters (HQ).
- For the Navy, ₹40,000 is granted by the Indian Navy Benevolent Fund (INBF).
- For the **Air Force**, ₹7,500 is provided under the supervision of the Air Force Association (AFA) or the nearest Air Force Station. Additionally, ₹15,000 is contributed by the Indian Air Force Benevolent Association (IAFBA) through the local Air Force Unit or AFA.

The financial grant is provided as soon as the death is reported or upon submission of the death certificate. If there is no NOK or if requested by the family, the field staff will take charge of organising the last rites. In cases where a veteran dies in a location different from where they are registered or is not affiliated with any canteen, the nearest Station HQ or canteen will provide the grant, which can later be reimbursed by the dependent canteen.

Documentation Required

- Death Certificate: 2 copies
- Identity Cards: of the deceased and the NOK 2 copies each
- Passport-sized Photographs: of the NOK 3 copies
- Cancelled Cheque or Bank Details of the NOK showing IFSC and MICR code 1 copy
- Photocopy of the Bank Passbook: 2 copies
- NOK Registration Form: 2 copies

Process of Claiming ADLRS

Upon the demise of a veteran, the family or next of kin must notify the Station HQ closest to their location. The required amount will be paid by the unit to the NOK, which will then be reimbursed from the veteran's dependent Unit Run Canteen (URC). If the veteran passes away in a different location or is not registered with a local canteen, the nearest canteen or Station HQ will provide the amount, which can later be claimed from the dependent canteen.

Dedicated Helpline for ADLRS

A dedicated helpline (1904) has been established for informing Army authorities about the demise of a veteran and initiating the process for organizing last rites. Families can call this number from anywhere in India, and the exchange operator will connect them with the nearest Station HQ. A designated officer from the HQ will then contact the family to arrange all necessary support for the funeral.

Guidelines for Implementation

Each Station HQ will assign officers to ensure the smooth implementation of the scheme. These officers will coordinate all necessary arrangements, ensuring that every step aligns with the Standard Operating Procedure (SOP) of the ADLRS. The Station Commander and other senior officers may also become involved, depending on the rank and status of the deceased veteran, to ensure a fitting farewell.

Conclusion

In summary, the Assured Decent Last Rites Scheme reflects the commitment of the Indian Armed Forces to honour the veterans who have served the country. By providing financial assistance and support for last rites, the ADLRS ensures that veterans are respected and remembered with dignity even after their demise. The implementation of this scheme across the Army, Navy, and Air Force underscores the comprehensive coverage and dedication of the armed forces to their veterans and their families

FAMILY PENSIONERS AND COMMUTED PENSION

Pensioners have the option to get the pension commuted at the time of their retirement. If the pensioners opt for this, the commutation amount will be deducted on monthly basis from the pension for a pre-defined period of time. However, if the pensioner unfortunately passes away before the completion of above mentioned pre-defined period, the family pensioner will get full pension without deduction of the commutation installment amount (Authority: GOI, Ministry of Personnel Letter No. 42/15/2022- P & PW(D)/5 dated: 25 Oct, 2022.

Recently few references regarding matters on delayed payment of GPF to the retired Government have been received for clarification whether interest is payable on GPF after retirement.

- 2. In this connection, it may be stated that detailed clarifications regarding timely payment of GPF final payment to the retiring Government servant were furnished to all Ministries/ Departments vide this Departments' Office Memorandum No 3/3/2016- P & PW (F) dated 16 January, 2017.
- 3. As per Rule of 34 of General provident Fund (Central Service) Rules 1960 clearly provides that when the amount standing at the credit of a subscriber in the General Provident Fund becomes payable, it shall be duty of Accounts Officer to make payment.
- 4.It is also added the amount deposited in General Provident Fund Account is solely by the asset of individual Government Servant. Any disciplinary case pending or penalty imposed against him does not have any impact on the disbursement of the GPF amount. As per Rule 11(4) of GPF Rules, in case the GPF balance is not paid on retirement, interest on GPF balance is required to be paid for the period beyond the date of retirement also.

Reference is invited to this office Circular No 228 dated 19.07.2023 regarding issue of NO OBJECTION CERTIFICATE (NOC) to banks from PCDA(P) Prayagraj office for closure of Defence pensioner's/family pensioner's bank account who are drawing pension through SPARSH and final withdrawal by their nominees. In order to further streamline the process, instructions issued vide this office earlier Circular No 228 is hereby cancelled in toto
- 2. Henceforth, following procedure may be adopted for release of amount lying in the account of deceased Defence- pensioner/ family pensioner who are drawing their pension through SPARSH to their nominee.
- (a) In cases where family pension is being sanctioned /paid through SPARSH. any excess amount disbursed after death of pensioner /family pensioner is being adjusted from arrears/monthly family pension from next to kin. Hence, bank will release amount available into deceased pensioner's/family pensioner's account as per banking nomination rule without waiting any reference from PCDA(P) Prayngraj. Copy or Corrigendum PPO certifying sanction of family pension or monthly family pension payment slip generated from SPARSH can be, however, verified by the bank for ensuring sanction of family pension while releasing the amount lying in the pensioner's bank account to the nominee.
- (b) In case there no eligible beneficiary is available for receipt of family pension settlement of amount lying in the pensioner/family pensioner bank account shall he regulated as under.

(I) Wherever family pension is not being sanctioned or no eligible family pensioner is available in family hierarchy for claiming family pension. Bank will allow to withdraw the amount available in deceased pensioner/family pensioner's account which was credited available in the account prior to the month of demise of pensioner/family pensioner to the bank account nominee as per banking nomination rules without waiting for any reference from PCDA(P) Prayagraj. Any amount credited on account of account during the of Defence pension during the month of death or thereafter into the account of pensioner/family pensioner. will not be released by bank to the nominee.

- (ii) PCDA(P) Prayagraj will convey details of demand to the bank for refund of excess amount remitte to the decease Defence pensioner /family pension post date of death for final settlement of deceased account
- (iii) PCDA(P) Prayagraj will convey the details of refund to bank after two months of approval or demise reported for the pensioner/family pensioner to the ensure that no claimant is available for family pension. Remaining amount, if any left in the amount of the deceased pensioner/family pensioner after refund will be released by the bank for final settlement and closure of bank account. In case any request for sanction of family pension is received, such refund letters will not be issued and account residue will be settled as per instructions at 2(a) above.
- 3. All receipt of detail for refund from PCDA(P) Prayagraj bank will remit the amount immediately into the PCDA(P) Prayagraj account maintained with RBI through NEFT.

SUBJECT: GUIDE LINES FOR AVALING TREATMENT BY ECHS BENEFICIARIESE FOR OCCUPATIONAL THERAPY, SPEECH THERAPY, AND APPLIED BEHAVIOUR ANALYSIS (ABA) BASED BEHAVIOURAL THERAPY IN INDIVIDUALS WITH AUTISM SPECTRUM DISORDER (ASD)/ NON AUTISTICPERSON /CHILDEREN WITH ADHD AND SPECIFIC LEARNING DISABILITIESE.

- 1. Refer MoH&FW OM No. S11030/86/2022-EHS Dated 01May, 2023(copy enclosed)
- 2. The guidelines for availing treatment under ECHS for occupational therapy, Speech Therapy, and Applied Behavior Analysis (ABA) Based Behavioral in individuals with autism spectrum disorder (ASD)/non autistic person/children with ADHS and specific learning disabilities are laid down as under.
- 3. Aim of Occupational therapy/speech therapy /Applied behaviour Analysis based behavioural therapy (ABA) /special education in individuals with autism spectrum disorder: - The therapies aim towards minimizing the sensory issues, motor & praxix related problems challenging behaviours, decreased social communication and difficulties in the activities of daily living (ADL) experienced in home, school, and community. This in turn

improves the levels of independence in ADL, acquisition of significant like skills, promotes community integration and mainstreaming of individuals with autism spectrum disorders.

- 4. Who can diagnose ASD for purpose of reimbursement? Reimbursement for therapies after diagnosis of Autism Spectrum Disorder will be done if prescribe by pediatrician/ Development pediatrician/Pediatric Neurologist/ Psychiatrist/child and Adolescent Psychiatrist in Service Hospital or ECHS Empaneled Hospital/ Govt. Hospital.
- 5. Ceiling rates the therapy session: The ceiling rates for occupational Therapy, ABA based therapy, speech therapy and special education for individual with Autism Spectrum Disorder Under ECHS shall be Rs. 400/-per session irrespective of the type of session.
- 6. Eligible Centers: Any center (Empaneled or Non-Empaneled) providing therapy services administered by qualified personnel having minimum qualifications (Table-I) as summarized as under:

- 7. Eligibility to Obtain reimbursement for occupational Therapy /speech Therapy / Applied Behaviour Analysis based behaviour therapy (ABA) / Special Education Services:
- (a) Beneficiaries shall be eligible to receive the proposed therapy if:
- (i) They have been evaluated and diagnosed to have autism spectrum disorder as per the standard protocol out lined by the committee.
- (ii) The said therapy has been recommended as a necessary component in the management of the affected individual with autism spectrum disorder.
- (b) The therapies can be taken at empanel or non-empanel centers but reimbursement would be done as per the ceiling rate or as per actual whichever is less subject to the condition that
- (I) Provision of therapy session notes as per the format (Basic minimum standard guidelines for recording and therapy report) published in the gazette by the central mental health authority as per provisions of the Mental Healthcare Act 2017(Appx).
- (ii) The therapists are recognized by the competent authorities of their respective fields as documented in table 1 (para 6)
- (c) The beneficiary has undergone a detailed assessment by the therapist including sensory profile/ sensory checklist, level of communication, social interaction, stereotypic and repetitive behaviour, impact on the school environment/ home, impact on motor/ sensory function, activities on daily living behavioral issues that need to be addressed, parental perception of problems, family coping, strategies, expected family support/ motivation an expected compliance for the therapy.
- (d) As autism requires multidisciplinary management it was proposed that reimbursement should include at least two or more types of therapy including any ABA based behavioural therapy ,occupational therapy, speech and language therapy, special education, unless only one type of therapy is available within the reach of the beneficiary.
- (e) Individualized therapy plan: The therapist has to provide a written individualized therapy plan (ITP) customized for therapy that specific the following:
- (i) Short term goal: those that are expected to be achieved in three months.
- (ii) Long term goal: those that are expected to be achieved within a year.
- (iii) Home based plan.
- (iv) The schedule and frequency of sessions required to achieve the short-term goals. This will depend upon the severity of the behavioural issues, the phase of therapy, and the compliance of the caregivers to therapy.
- (v) Therapy recorded each session: a specific written plan that details home assignments given to parents/caregivers- the details of activities, how to administer them, the frequency, the duration etc.
- (vi) A structured operational system to monitor compliance of caregivers with the home assignments.
- (vii) A structural operational system for regular evaluation of the impact of the therapy on the functioning of the affected individual.
- 8 Frequency of therapy sessions:
- (a) Duration of each session should be at least 40 minutes
- (b) It should be based upon the severity of Autism as diagnosed by the referring clinician and as recommended

- 1.It is with deep pain that I am conveying my feelings. These are not my feelings alone but of a majority of Veterans.
- 2.It is to do with the removal of the historic picture of 1971 surrender ceremony from the COAS' Lounge. Post World War-2 this is the first victory of its kind where surrender of a nation took place. Before this the Allies took surrender of the AXIS power Countries at end of WW-2.
- 3. What this photo has been replaced with is the decision of the COAS. But questions do arise because it affects us. The new photo or painting, whatever it is, looks as if a child has painted it in some school level painting competition. Pangong Tso with mountains in the background, some military equipment. What is the significance? We have lost our patrolling rights from Finger 4 to 8 I know this because I commanded the then neglected 114 Inf Bde from 2001 to 2003. Then we have Chanakya. Do we go by what was taught by him about 2400 years back? If his philosophies were so sound, India would not have broken into so many regions, kingdoms, principalities etc. And weren't the British wise they brought all of them into one geography and today Armed Forces are a result of that success and not Chanakya.
- 4. And finally you have the chariot probably reflecting Mahabharat. Wonder why bring religion into the Armed Forces? Do we want to dismantle our edifice and remove our roots? What relevance does it have with regard to our armed forces today?
- 5. I'll be grateful if the historical photo of 1971 surrender removed from COAS' Lounge be gifted to IESL. We'll give it a place of honour. Our office used to adorn the photos of the Chiefs and now also of CDS after its creation. This year three Chiefs have retired. I decided not to spend money in placing the new photographs because none of you have shown any interest in resolving the issues raised by IESL and other Veteran organizations.
- 6. As the subject of my letter says, photo finishes are always admired, be it the winner or the narrow loser. But to finish photos which reflect history is an unpardonable act. I feel this is only a part attempt. Yesterday my 69 Armd Regt celebrated Bogra Day Battle Honour of 1971 at Manekshaw Centre. We took a photo of over 60 serving and Veterans and ladies who travelled from all over the country for the event. The photo was taken with Field Marshal Manekshaw's statue in the background. I wonder why not name it 'Chanakya Centre' and replace our beloved Field Marshal Sam Manekshaw's statue with that of Chanakya.
- 7. Leave the decision to you. But let me place a challenge. None of you will.ever attain the stature of Field Marshal Sam Manekshaw. There is no country you can overrun in your tenures. Even the Haryana election commitment of our senior political leaders that within six months we'll take back POK will not materialize.

PROTECTION OF ENVIRONMENT: CARBON CREDIT SYSTEM

1. Protection of the environment is the responsibility of every section of our Society. With our background of military, I can say there is no organization better than the Armed Forces which has played a significant role in the greening of the country. To this extent Eco Battalions were raised which have done a commonable job in Uttarakhand and

- 2. Our Green Cover is amongst the lowest in the world and our human and animal population is a big contributor to the damage being caused to the environment and generation of greenhouse gases. We may undertake any amount of initiatives but there is no way we can overcome this factor. Our water bodies are not worth taking a second look, plastic waste is choking our water bodies and landfill sites. And frankly very little trust is left in the govt initiatives.
- 3. I wouldn't talk of the damage caused to the air, soil and water by the industry. Why? Because PHDCCI and other industry bodies are representative of these industries and truth may not be palatable. The small-scale industry such as dyeing, electroplating, leather etc cause immense damage to the environment. What is the way out?
- 4. If we go by our tree plantation record over the decades, India would not have been visible under the green cover. Crores of trees planted by forest depts, social organizations and individuals. Where are they? They are mostly on paper and funds usurped. The solution lies in farm lands being converted to 'forests'. Farmers do plant poplar, eucalyptus and other species but these are primarily for their livelihood. These are cut down anywhere between 5 to 25 years. Why not give carbon credits to farme to keep these trees alive? Since Carbon credits may not meet their financial needs they can be asked to replace old trees in a phased manner so that the entire green cover is not lost in one go. New plants, say 20 to 25% replacing old trees every year. This would improve the environment in a every way.
- 5. The Eco Battalions raised by the Army are expensive to maintain because of overheads. Why can't the Ex-Servicemen (ESM) be utilized for this. Land holding in India is small. But we have large unused land along the railway lines and highways. The forest departments are deep rooted in corruption. IESL can create these Eco Battalions with supervisory staff of ESM and youth employed for plantation and maintenance. The MGNREGA funds are also grossly misused with no accountability. CSR, MGNREGA funds for plantation on govt lands through ESM would make a lasting difference. IESL is prepared to take on this project.

The Department of Pension & Pensioners' Welfare (DoPPW) vide O.M. No.1/4/2017- P&PW(F) dated 3rd October, 2017 had conveyed that the rate of Constant Attendant Allowance payable to the Civilian pensioners shall be increased by 25% every time the dearness allowance on the revised Pay in the Pay Matrix is increased by 50%.

- 2. Do PPW vide O.M. of even number dated 18.09.2024 (copy enclosed) has requested all Ministries /Departments to enhance the amount of Constant Attendant Allowance by 25% from the existing Rs.6750/- to Rs.8438/- per month with effect from 01.01.2024.
- 3. All the Ministries / Departments may please bring the above to the notice of all concerned.

REGARDING ONE RANK ONE PENSION(OROP)

- 1. Refer your letter No. IESL/105/2024/dated: 05 Sep, 2024
- 2. Parawise comments on the issue raised in your ibid letter is as under:

(a) OROPANOMALIES.

- (I) OROP implies that uniform pension will be paid to the Armed Force & personnel retiring in the same rank with the same length of service regardless of their date of retirement. Future enhancements in the rates of pension would be automatically passed on the past pensioners. This implies bridging the gap between the rate of pension of current and past pensioners at periodic intervals.
- (II) Hon'ble Supreme Court on 16 March, 2016 has upheld the principle and modalities of OROP issued by Ministry of Defence on 7 November, 2015.
- (III) OROP table for 2024 are already out in public domain, where in total 121 tables indicating of rates pension /family pension under OROP scheme have ben given and where the revised pension as on 01July 2024 worked out in terms of these orders, happens to be less than the existing pension/family pension as on 01 July 2024, the pension shall not be revised to te disadvantage of the pensioner/family pensioners.
- (IV) Present revision wef 01 July 2024 has been done on time. Next OROP revisions will be due in July 2029, 2034 and so on after every five years. In addition to the benefit of OROP, benefits of pay commission will also be provided. Hence in the ten years spell, three revision of pension will be made.

(b) SPARSH:

- (I) SPARSH is CGDA driven project implemented in Armed Forces from August 2021. Since its inception, Service HQ have been facilitating CGDA, PCDA(P) and TCS to stabilize SPARSH so that our veteran's fraternity should continue to draw their legitimate pension hassle free. For any project, there would be issues at the initial stage and hence, SPARSH also faced stabilization issues. However, with the following initiatives of service HQ, most of the issues are resolved:
- (aa) Time team from TCS is positioned at PCDA(P) at behest of AG.
- (ab) Regular meeting with MoD, CGDA/TCS
- (ac) Distribution of work to CDA(PD) Meerut (Re-emp, MLC, Income tax conviction/stoppage of pension & bank related issues) and CDA Chennai (IFP and Aadhar updated requests).
- (ad) Joint Control Group functional at CENTRAD, Delhi Cantt. (Services, CGDA & TCS).
- (II) Service HQ have constantly been raising the remaining issues with O/o CGDA, PCDA(P) & TCS through Def Secy.

(C) Additional Pension on attaining 80 years age:

- (I) Apensioner on attaining the age of 80/85/90/95/100 years is entitled to additional pension as per prescribed rates ie 20%/30%/40%/50%/100% of the basic pension respectively. This provision is applicable to Defence personnel employees well as civil govt employees.
- (II) Hon'ble High Court Gauhati had given relief by granting additional pension on attaining the age of 79 years i.e1st day of 80th years. The judgement of Hon'ble High Court of Gauhati is contrary to the extant policy. Clarification on the matter has been sought from MoD/D/ (Pen/Pol). MoD/DESW has intimated that the ibid Judgement is specific to Judgse, however they have taken up the matter with DoP & PW, being the nodal department of pensionary matters. MoD has also intimated that further action on matter will be taken after receiving comment of DoP& PW.

C Reduction Period of Restoration of Commuted Value of Pension

(I) The restoration of pension after 15 years was based on a judgement passed in 1986 by Hon'ble Supreme Court of India. As per Reg -163 of PRA, Part-I (2008), "The Pensioners

who have committed the admissible portion of pension are entitled to have the commuted portions of pension restored after 15 years". There is no provision of revising the period of commuted value of pension before 15 years as on date.

(II) Based on a petition to restore the commuted value of pension after 12 years, AFT(PB) New Delhi had directed vide their order dated 24 July 2024 that recovery of the pension after 12 years be stayed. The ibid order has been stayed by Hon'ble High Court of Delhi vide ordered at 11 Sept, 2024.

- 1 An emergency helpline no155306 has been established at Army HQ Provost unit to provide serving solders and veterans a facility similar to dial '100' for providing relief and assistance in case of crisis situation. This single window system will address mobile and landline calls for urgent help line in case of emergency situation such as traffic accidents, medical crisis, natural calamities major criminal activities and requirement of Immediate help.
- 2 **Features:** The universal helpline has the following features:
- (a) The helpline is manned 24*7 hours by a professionally trained team of MPs and WMPs.
- (b) The helpline is equipped with call identification and call recording facility.
- (c) The helpline is access to all Provost Unit/ Fmn HQ through ASCON and too civ police and other concerned civil development through civil landline network.
- (d) The caller can dial the Emergency Helpline Number from any part of the country using any type of service provider such as Airtel, JIO, VI and BSNL.
- (e) The helpline has Call barning facility to discourage people calling for routine information.
- 3. **Process** In the event of any emergency situation, the call will be processed as under:
- (a) The Caller will '155306' without using any prefix.
- (b) The caller will be asked identify himself/herself giving No, Rank, Name and Location.
- (c) A brief of incident will be sought.
- (d) The Help desk will be then call up the nearest Provost unit/ Police station to activate response to the place of incident.
- (e) A response form will be generated by the help desk through Call Management System Software to track and obtain feedback for closure of the cases.
- 4. Exclusion- The fwg aspects will be excluded from reporting through Emergency Helpline Number:
- (a) Land Dispute Case.
- (b) Marital Discord cases.
- (c) Toll Exemptions.
- (d) Case which are Subjudice
- (e) Family Matters.
- (f) Incidents of Matters.
- (g) Routine enquiries.
- 5. The reports generated through Army Helpline Number will be fwd to concerned fmn for required action. The after action report by the concern fmn will be fwd to Army HQ Provost unit for closure of the case.
- 6. Army Helpline Number will not be used to seek information related to military aspects.
